List of Restricted Assault Weapons

Anything on the above list cannot be shipped to Connecticut

Any device, component, part, combination of parts, attachment, or accessory that increases the rate of fire of any firearm, including but not limited to bump stocks, trigger cranks, and binary trigger systems is prohibited.

Rifles

The following are prohibited:

- Semi-automatic, centerfire rifle that has an ability to accept a detachable magazine and has at least one of the following:
 - 1. A folding or telescoping stock
 - 2. Any grip of the weapon, including a pistol grip, a thumbhole stock, or any other stock, the use of which would allow an individual to grip the weapon, resulting in any finger on the trigger hand in addition to the trigger finger being directly below any portion of the action of the weapon when firing.
 - 3. A forward pistol grip
 - 4. A bayonet mount
 - 5. A flash suppressor
 - 6. A threaded barrel
 - 7. A grenade launcher or flare launcher
 - 8. Magazine Capacity over 10 rounds

A semiautomatic, centerfire rifle that has a fixed magazine with the ability to accept more than ten rounds; or a semiautomatic, centerfire rifle that has an overall length of less than thirty inches.

- ✗ Any Semi-auto, centerfire rifle that has an ability to accept a magazine with a capacity exceeding five (5) rounds is prohibited to any person under twenty-one years of age.
- 22 Rimfire rifles that are semi-auto with ability to accept detachable magazines and any two of the following features:
 - 1. Pistol grip
 - 2. Folding / telescoping stock
 - 3. Bayonet mount

- 4. Flash suppressor
- 5. Threaded barrel

× No upper or lower AR or AK receivers.

Shotguns

The following are prohibited:

- **X** A semiautomatic shotgun that has both of the following:
 - 1. A folding or telescoping stock; and
 - 2. Any grip of the weapon, including a pistol grip, a thumbhole stock, or any other stock, the use of which would allow an individual to grip the weapon, resulting in any finger on the trigger hand in addition to the trigger finger being directly below any portion of the action of the weapon when firing
- X A semiautomatic shotgun fixed magazine over 5 rounds
- **X** A semiautomatic shotgun that has the ability to accept a detachable magazine.
- **X** A shotgun with a revolving cylinder.

Handguns

The following are prohibited:

- A semiautomatic pistol that has an ability to accept a detachable magazine and has at least one of the following:
 - 1. An ability to accept a detachable ammunition magazine that attaches at some local outside of the pistol grip.
 - 2. A threaded barrel capable of accepting a flash suppressor, forward pistol grip or silencer.
 - 3. A shroud that is attached to, or partially or completely encircles, the barrel and that permits the shooter to fire the firearm without being burned, except a slide that encloses the barrel.
 - 4. A second hand grip.
 - 5. A semiautomatic pistol with a fixed magazine that has the ability to accept more that ten rounds.
 - 6. Manufactured weight of 50oz or more.
 - 7. Magazine capacity exceeding 10 rounds.
- X No Walther PPQ M2 handguns (Only M1). Other Walther restrictions can be viewed <u>here</u>.

Other Firearms

The following are prohibited:

- Any semiautomatic firearm other than a pistol, revolver, rifle or shotgun that has at least one of the following:
 - Any grip of the weapon, including a pistol grip, a thumbhole stock or any other stoc the use of which would allow an individual to grip the weapon, resulting in any finge on the trigger hand in addition to the trigger finger being directly below any portion the action of the weapon when firing.
 - 2. An ability to accept a detachable ammunition magazine that attaches at some local outside of the pistol grip.
 - 3. A fixed magazine with the ability to accept more than ten rounds.
 - 4. A flash suppressor or silencer, or a threaded barrel capable of accepting a flash suppressor or silencer.

- 5. A shroud that is attached to, or partially or completely encircles, the barrel and that permits the shooter to fire the firearm without being burned, except a slide that encloses the barrel.
- 6. A second hand grip.
- 7. An arm brace or other stabilizing brace that could allow such firearm to be fired fror the shoulder, with or without a strap designed to attach to an individual's arm.

X No Remington Tac-13, Emperor Mogul Max Ultra or similar models.

Accessories / Ammunition

We do not ship magazine extenders or extensions.

Any device, component, part, combination of parts, attachment, or accessory that increases the rate of fire of any firearm, including but not limited to bump stocks, trigger cranks, and binary trigger systems is prohibited.

- The following combination of firearms parts designed or intended to convert a semi-automatic firearm into an "assault weapon" are prohibited:
 - 1. Folding, Telescoping, Thumbhole or Pistol Grip stocks
 - 2. Pistol Grip
 - 3. Vertical Grips
 - 4. Bayonet Mount
 - 5. Flash Hider/Flash Suppressor/Muzzle brake
 - 6. Threaded Barrel
 - 7. Grenade Launcher
 - 8. Upper Receivers that can be used to build an "assault weapon", including but not limited to AR and AK receivers
 - 9. Barrel Shroud
- X No magazines exceeding 10 rounds.
 - No Walther PPQ M2 magazines
 - No Walther PPX M2 magazines
- X No online bulletproof vest sales.

CONNECTICUT

- X Only holders of a valid CT Carry Permit, Eligibility Certification, Long Gun Eligibility Certificate, or Ammunition Certificate and a State-Issued Photo ID will be able to purchase ammunition and/or magazines. Armor Piercing and Incendiary .50 caliber bullets and loaded ammunition are prohibited.
- **X** Unserialized 80% frames or receivers are prohibited.

Law enforcement officers are exempt from "assault weapons", high-capacity magazine and ammunition restrictions listed above with Department Letterhead authorizing the purchase.

Active-duty military with current military ID are exempt from "assault weapons", high-capacity magazine and ammunition prohibitions listed above with letter from commanding officer stating item(s) will be used for official duties.
